29TH AUGUST 2013.

I hereby inform your office, the above recd. reports has been happen in my Area since 29th July 2013 on 29th August 2013. which I am request some Emergency Assitancees from wellwishes to families which lost their people in that raids, which was occured rapidly in my area and families, those lost the Nets and fishing boats taken by Dasseench from Ethiopia. If aid will provided to Deceased families those left Vulnerable will happy. This is occuram reports.

The 1st incident report was occured on 29/7/2013 at Meret at the shore of the Lake, where Turkana fishermen, Exchange firearms with Dasseench from Kenya. The Dasseench from Ethiopia took 400 Nets of Turkana - 80 families left without nets

The 2nd incident report was happen on 1st August 2013, the Dassench from Ethiopia attack turkana fishermen at Todonyang area, when fishing place called Lopel delta. 4 fishermen were killed. The properties taken by was follows; 1 wooden boat, 1 G3 gun and 36 Fishing nets. These people are from Nayenae kabarin village in Kanamulungy sub-location. 40 families were left Vulnerable without.

The 3rd incident report was happen on 10th August 2013, The Dassench from Ethiopia stolen 5 wooden Boats from Nayenae kabarin village at Kanamulungy sub location at night in the shore of the Lake. 80 families were left Vulnerable without fishing boats.

The 4th incident report was happen on 11th August 2013, 7 people fishermen from Nayenae kabarin were killed by Dassench from Ethiopia at Todonyang area at place called Nasawat near Catholic mission in the Lake at time 5.00 pm. The following properties was taken by Dassench 2 wooden boats, 3 G3 guns from 3 Kip.R killed plus and 3 ordinary fisher-men. 120 families left Vulnerable without fishing gears. Please to people concern you can see summary of report analysis attached. With the cost of properties taken by Dassench from Ethiopian. The 4th incident report which was happen on 29th August 2013, when again Dassench from Ethiopia attacked turkana and 3 people, 1 Died
